PROGRAM REPORT

1. (a) Development Review

Andrew Bicknell, Regulations Coordinator presented the Development Review report pursuant to Ontario Regulation 147/06 Development, Interference with Wetlands and Alterations to Shorelines and Watercourses. Through the application process, proposed developments within regulated areas are protected from flooding and erosion hazards. Staff granted permission for 2 *Applications for Permission* and 9 *Minor Works Permits*.

1. (b) Violation/Appeals Update

Geoff Cade reported that staff have met with the municipality and other agencies who have concerns with the opening of Windmill Lake Wake & Eco Park in Central Huron. The owners have built structures and done excavating without permits

2. Five Year Budget

Brian Horner, General Manager presented the five year budget for approval. At this time, funding for the Drinking Water Source Protection Project and the Weston Family Environmental Leaders of Tomorrow Program at Camp Sylvan is unknown and may impact future budgets. Based on the programs and projects proposed over the next five years, the general levy increase is 3.64% and the new or ongoing projects show an increase of 8.04%.

Brian Horner presented the profit & loss statement to June 30, 2014 with comparatives to the 2014 budget.

4. MacNaughton Morrison Trail 10th Anniversary

Kate Monk, Stewardship, Lands & Education Manager gave an update on the activities and events undertaken throughout the year to celebrate the milestone. A volunteer committee has produced a new South Huron Trail information brochure, two nature videos identifying the wildflowers and trees along the trail, newspaper column series highlighting how the trail changes through the seasons. A celebration is being held Saturday, September 27th with breakfast by the Exeter Lions Club, guided hikes and fitness challenge along the trail and a landowner appreciation ceremony.

PRESENTATION

Mari Veliz, Healthy Watersheds Supervisor gave a presentation on the information gathering project to document water quality improvements from agricultural BMPs. The study was done along the lakeshore north of Bayfield in the Gully Creek watershed and the Ridgeway Drain watershed in the Zurich area and looked at cover crops, conservation tillage, water and sediment control basins and nutrient management, to measure the effect of BMPs on phosphorus concentrations under low and high flow events.

Typically during heavy rainfall events, high flows erode the channels leading to sediment being carried into the watercourse. To help landowners assess their properties, staff walked the farms with the landowner to map drainage patterns and determine some remedial measures. A systematic approach to dealing with pollutants through best management practices is to Avoid, Control, Trap/Treat (ACT).

Evaluation includes regular water sampling data collection. In the past staff didn't know the landscape surrounding the sample location, so now there is more data for analysis (eg. corn field). Local volunteers have been trained as citizen scientists to increase the data collection during storm events (eg. Bayfield Beach). Soil health information is now available in the watershed report card. There is a better understanding of water quality indicators under wet and dry conditions. Community outreach and water quality monitoring are the main objectives of the ABCA healthy watersheds program.

Brian Horner provided a written report with a brief update on the progress of various projects, staff training and development, upcoming meetings and activities held over the previous month.
