#### 1. Bendway Weir Project

Tom Prout, General Manager reported on the Committee of Revision meeting held on April 25, 2009 in Port Franks to discuss the landowner contribution towards the Bendway Weir project. The breakdown, determined when the project was initiated, was 50% provincial grant, 5% general levy and 45% from benefitting landowners. An Ontario Municipal Board hearing confirmed the Environmental Protection - Hazard zoning of lands owned by the Municipality and the ABCA. Under this zone, these lands are considered unbuildable, therefore no benefit from the project as landowners. The municipality, however, has requested the ABCA contribute \$66,000 towards the project. In anticipation of being assessed a portion of the project costs, the ABCA has collected \$50,756.

Geoff Cade, Supervisor of Water & Planning provided a verbal update on current legal issues staff are involved with. A landowner in Municipality of Lambton Shores was charged with a violation and has verbally agreed to plea guilty. A restoration plan is underway on the property.

#### LUNCH & LEARN SESSION

Through partnerships the project will introduce beneficial conservation practices for agriculture and improving water quality in the Bayfield River.
