I will not act in collusion with anyone on ABCA land or adjacent private land who does not have an ABCA Conservation Pass. 					
6.	e. I will not destroy or damage any trees, trails or buildings on ABCA property. I agree that any tree stand will only be on site when I am hunting. The stand will not be attached to the tree by any method that penetrates the tree. The ABCA has the authority to remove and retain any tree stand that is not in compliance.
