Proceeds from the Hunting Permit maintain Ausable Bayfield Conservation Authority (ABCA) properties for everyone to enjoy. For your safety and protection of the environment, hunting is only permitted on ABCA conservation lands with a Hunting Permit. Your permit is valid for 12, 24 or 36 months from date of purchase. **Off-road vehicles are NOT permitted on ABCA properties.**
