FUNDING PRESENTATION

In honour of the 40th anniversary of the Bayfield River watershed joining the Ausable River Conservation Authority on July 21, 1971, the Board of Directors held their meeting in Bayfield. At the commencement of the meeting, Hon. Carol Mitchell, MPP for Huron-Bruce attended and made a funding announcement to the Ausable Bayfield Conservation Authority (ABCA) and Maitland Valley Conservation Authority (MVCA). The Ontario Ministry of Agriculture, Food and Rural Affairs (OMAFRA) is working to protect and improve water quality along the southeast shore of Lake Huron by investing \$150,000 in three projects. One of those projects is a community-based Sub-Watershed Plan for the Main Bayfield River. ABCA will receive \$60,000 for the completion of a water management strategy for the Main Bayfield River watershed.

The Huron Clean Water Project will receive \$20,000 from OMAFRA to assist property owners and community groups with stewardship projects to improve surface and ground water quality. Some project categories include erosion control measures, livestock fencing, wellhead protection, well decommissioning and manure storage. The program delivery is co-ordinated by the ABCA and MVCA.

The MCVA will receive \$70,000 for soil erosion projects in the Garvey/Glenn Watershed Project, one of the key watersheds identified under the Southeast Shores Water Quality Initiative. Landowners in the watershed have identified storm water management and erosion control as priority issues and the MVCA is helping coordinate an effort to address these concerns.

Chair Jim Ginn, ABCA General Manager Tom Prout and MVCA General Manager Phil Beard each responded with appreciation for the provincial commitment in assisting farmers and rural landowners to continue stewardship efforts for protecting and improving the water quality of Lake Huron.

Guests attending the announcement were staff of MVCA and regional OMAFRA & MOE offices.

Walker Drain Area 1 Erosion Control Tender

Alec Scott, Water & Planning Manager presented the tender results on the Walker Drain Area 1 Erosion Control project. The work involves repair of an eroding bank affecting a municipal sports field along the Walker Drain in Grand Bend. The tender opening was held on July 12, 2011 with Peter Crook of Riggs Engineering Ltd., Dave Frayne and Alec Scott in attendance. There were 8 tenders submitted with Van Driel Excavating Inc. being the lowest. The engineering consultant reviewed the tenders and recommended the lowest tender.

PROGRAM REPORTS

1 (a) Development Review

Andrew Bicknell, Regulations Coordinator prepared the report on the Development Review pursuant to Ontario Regulation 147/06 *Development, Interference with Wetlands and Alterations to Shorelines and Watercourses*. Through the application process, proposed developments within regulated areas are protected from flooding and erosion hazards. Staff granted permission for two *Applications for Permission* and four *Minor Works* applications.

1 (b) Violations update pursuant to O. Reg 147/06

- (i) Andrew Bicknell advised of the updates to two violations pursuant to O. Reg. 147/06. The violation in the Municipality of South Huron on Parr Line is in the court system. The solicitors for both parties are in communication and ABCA staff are expecting an update before the next court appearance in August.
- (ii) Staff have recently learned about a violation along the lakeshore in Green Acres subdivision. Unauthorized work has been undertaken by the landowner to fill and grade within the ravine area.

Bill Siemon asked what the costs are for ABCA staff having to deal with the ongoing violations. Tom Prout responded that staff will bring back a report at the September meeting on staff time and associated costs with violations.

2. Section 29- Conservation Authorities Act

Kate Monk, Stewardship & Conservation Lands Supervisor presented an report on activities pursuant to *Section 29* of the *Conservation Authorities Act*. Patrol officers are finding the greatest problem area for unauthorized use of off-road vehicles is at the Parkhill Conservation Area and the Kime Tract. There is an agreement with the Ausable River Riders Club to maintain trails at a portion of the Parkhill CA but non-members are the challenge.

Several Special Use Permits for research on ABCA lands have been issued. They include turtle surveys at L-Lake Management Area and Rock Glen CA; research on bed composition and characteristics where mussel Species At Risk are found at Rock Glen CA and Sadler Tract in the Ausable Gorge; and terrestrial surveys at the Linfield Wildlife Area, Ratz Tract and Sweitzer Tract Conservation Forests for background reports for potential wind generation projects.

The Arkona Lions Museum and Information Centre at Rock Glen CA will be celebrating its 25th Anniversary in conjunction with the Arkona Lions Classsic Car Show. The Ad Hoc Committee is

requesting permission for two vendors at the event - the Arkona Lioness to sell food and refreshments and Mr. Ron Watts an artifact expert to display native artifacts and sell jewellery in lieu of a speaker's fee.

3. Five Year Budget

Brian Horner, Financial Services Supervisor presented the five year budget with estimates at a 1.99% inflation factor and wages for ongoing projects and operations at 4% annual increase accounting for the Consumer Price Index plus movement on the pay grid. Of note was the expiration in March 2013 of the Drinking Water Source Protection project agreement with the province. Other highlights are a projected 5.89% increase in the general levy and 9.48% in the project levy. The combined levy average increase over the 5 years is estimated at approximately 6.5%.
