1 (a) Development Review

Andrew Bicknell presented the Development Review report pursuant to *Ontario Regulation* 147/06 Development, Interference with Wetlands and Alterations to Shorelines and Watercourses. Through the application process, proposed developments within regulated areas are protected from flooding and erosion hazards. Staff granted permission for 16 Applications for Permission and 22 Minor Works Permits to construct works within regulated areas.

2. Revised Communications Plan

Tim Cumming, Communications Specialist provided an overview of revisions to the 2006 ABCA Communications Plan. The updated plan reflects the increased use of community-based social marketing and accessibility to news online through mobile devices and social media. A companion document provides key messages for each department as well as target audiences and media outlets.

3. Conservation Authorities Act Review

Brian Horner, General Manager advised that the Ministry of Natural Resources & Forestry has posted a discussion paper on the EBR to review the *Conservation Authorities Act*. The deadline for responses is October 19, 2015. Correspondence has been sent to the CAO and council of each member municipality advising of the EBR posting. The four focus areas under review include: confirming the current conservation authority mandate; formalizing and expanding the CA working relationships across Ontario provincial ministries; discussing the governance model in relation to the funding model; and a sustainable provincial funding formula that captures the programs and services offered by conservation authorities.

PRESENTATION

Hope Brock, Healthy Watersheds Technician gave a presentation on the Community Turtle Monitoring Program. There are 8 native turtle species in Ontario of which 7 are ranked as species at risk - special concern (SC); threatened (T) and endangered (E). The turtles include snapping turtle (SC), painted, stinkpot (T), spotted (E), spiny softshell (T), blandings (T), map (SC), wood (E). The one non-native turtle is the red-eared slider, often kept as a pet.

Staff have conducted research in Port Franks and Grand Bend over the past six years, involving citizen science and community volunteers. In early May, a flyer is distributed asking the community to report any turtle sightings and record their observations such as species and habitats being used. There have been 600 reports to date. The information is then submitted to the Toronto Zoo Turtle Tally and becomes part of the Ontario Nature Reptile and Amphibian Atlas.

Reptile populations in Ontario are declining, so there is a need to protect them. Education and outreach displays, workshops and events have been held in Port Franks and Grand Bend bringing awareness of the species at risk turtles. Conservation and stewardship efforts have engaged landowners in becoming more involved in protecting turtle nests they find on their property. Also a number of turtle crossing signs have been installed. People are learning how to assist turtles across the road during the nesting season which results in countless turtles being saved. A turtle may not start reproducing until 20 years of age and they can live 50 to 100 years. It can take 1500 eggs to get 1 hatchling, so working with the community is important to increase the turtle populations.
